Proposed Legal Ethics Opinion 1856

Scope of Practice for Foreign Lawyer in Virginia

Deadline for comment: June 2, 2011

Proposed Legal Ethics Opinion 1856 develops the application of Virginia ethics rules to multijurisdictional practice in the commonwealth. The advisory opinion addresses a hypothetical Virginia law firm in which some of the partners and associates are licensed in other U.S. jurisdictions or a foreign nation, but not Virginia. The Ethics Committee examines under what conditions these "foreign lawyers," as defined under Virginia Rules of Professional Conduct 5.5(d)(1), can practice on a temporary basis or "continuously and systematically" under Rule 5.5. The opinion also addresses the conditions under which foreign lawyers can work for a Virginia law firm as contract attorneys.

Proposed Legal Ethics Opinion 1858

May a Lawyer Agree to Indemnify an Insurance Company as a Condition of Settlement?

Deadline for comment: June 2, 2011

Proposed Legal Ethics Opinion 1856 asks two questions: May a plaintiff's lawyer agree to indemnify a defendant or the defendant's insurer for a third-party lien claim against settlement proceeds received by the plaintiff? And may the defendant's counsel request or demand an indemnification agreement as a condition of settlement? The opinion concludes that the plaintiff's lawyer cannot ethically agree to pay an unreimbursed lien, nor can the defendant's lawyer make indemnification of the third party lien by the plaintiff's lawyer a condition of settlement.

APPROVED RULE CHANGES

RULES OF THE VIRGINIA SUPREME COURT PART 1A, RULE 1A:5

VIRGINIA CORPORATE COUNSEL

Effective: April 15, 2011

The Supreme Court of Virginia approved amendments to Rule 1A:5 that were proposed by the Joint Virginia State Bar-Virginia Bar Association Corporate Counsel Pro Bono Task Force and endorsed by the VSB Council. The Court amended the previous rule to lift limitations and expand opportunities for Part I corporate counsel, who are admitted in states other than Virginia, to do pro bono work subject to the VSB's regulatory authority while they do that work. The Court removed requirements that the registrants' work be supervised by a Virginia-licensed legal aid society, that the work be supervised by a legal aid lawyer or pro bono volunteer who is an active member of the VSB, and that limited the legal services the registrant could provide.

RULES OF THE VIRGINIA SUPREME COURT PART 6, § IV, ¶ 11 Dues

Effective: March 9, 2011

These amendments to Part 6, § IV, ¶ 11 of the Rules of the Virginia Supreme Court provide the Virginia State Bar with more flexibility for setting dues. Previously, Paragraph 11 required the VSB to charge \$250 for active members and \$125 for associate members. The new rule permits the VSB to charge up to \$250 for active members and \$125 for associate members. The VSB is required to report to the Court the proposed annual dues amount on or before April 1 for the following fiscal year.

Rules of the Virginia Supreme Court Part 6, IV, ¶ 13

Procedure for Disciplining, Suspending, and Disbarring Attorneys

Effective: February 17, 2011

These changes address the Virginia State Bar's procedures for implementing Court multijurisdictional practice rules, which regulate lawyers who are not members of the Virginia State Bar, but who are authorized to conduct a limited practice here.

Attorneys Not in Good Standing

Members of the Virginia State Bar who are not eligible to practice law because their licenses are suspended administratively or suspended or revoked for disciplinary reasons.

ATTORNEY NAME CHANGES

To change your name of record with the Supreme Court of Virginia and the Virginia State Bar, do the following:

- Fill out an "Attorney Name Change" petition. The petitions one for name change by circuit court order and another for name change by marriage are posted at http://www.courts.state.va.us/courts/scv/forms.html.
- Send to the Supreme Court with a copy of the certificate of marriage or court order. The address is at the bottom of the forms.
- Include a check for \$14 if you want a new certificate of qualification, or \$10 if you don't want a certificate.

Name changes take about a month to process.

Dues to Decrease for Fiscal 2012

On March 31, 2011, the Virginia State Bar Executive Committee approved a draft 2011-12 VSB budget that included a \$25 dues decrease for active members and a \$12.50 decrease for associate members. The Supreme Court has approved the dues decrease.

The new dues assessment of \$225 for active members and \$112.50 for associate members will be reflected in the dues that must be paid on or before July 31, 2011. The Clients' Protection Fund assessment will remain at \$25.

UPL STATUTE OF LIMITATION TO BE EXTENDED

The statute of limitation for prosecution of the misdemeanor of unauthorized practice of law (UPL) will change to two years from discovery of the offense by the complainant, under amendments to Code of Virginia § 54.1-3904 that go into effect July 1, 2011.

The legislation was requested by the Virginia State Bar's Standing Committee on the Unauthorized Practice of Law.

CALL FOR VOLUNTEERS

The Special Committee on the Resolution of Fee Disputes is seeking volunteers (lawyers and nonlawyers) to serve on its Circuit Committees on the Resolution of Fee Disputes.

There are currently eleven active committees in Virginia. They serve the 2nd, 10th, 16th, 17th, 18th, 23rd, 24th, 28th, and 31st circuits, as well as the Richmond metro and Norfolk-Portsmouth areas.

The committee also wants to establish committees in the 9th-15th (combined), 20th, 25th, 26th, and 27th circuits.

VSB Online Dues Renewal to Begin in June

Lawyers will be able to renew their Virginia State Bar membership and pay their dues online for the first time this year.

Online Membership Renewal will begin in early June, after paper dues statements have been mailed. The online option is available to members in good standing with active, active/Virginia corporate counsel, and associate memberships.

The new service will accept only individual attorney renewals.

Access will be provided through the secure "Member Login" area of VSB.org. Members who choose "Online Membership Renewal" will certify whether they are covered by a professional liability insurance policy, select what voluntary sections they wish to join, and pay their mandatory annual dues (including the mandatory \$25 Clients' Protection Fund fee), plus any section dues, by credit card.

The site will accept MasterCard and Visa, which can be applied through Online Membership Renewal to dues-related payments only. These include late fees that accrue after the membership compliance deadline of July 31. The membership renewal, insurance certification, and dues payment will be processed immediately, and a receipt will be issued.

Access to the Online Membership Renewal option will be available to members from early June until early October, when attorneys are administratively suspended for membership noncompliance.

When the access is available, the VSB will alert members through the monthly E-News and the "Latest News" section of VSB.org.

Online Membership Renewal is the first of several planned improvements to give members more flexibility and convenience through the VSB website. Eventually, the service will be expanded to include online renewals by groups of attorneys and charging of MCLE noncompliance fees and disciplinary costs.
