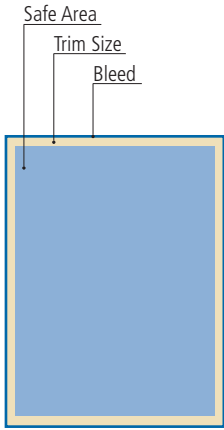

- Color requirements: All full color and ad artwork must be in process color (CMYK). No spot colors.
- Black must be 100% black (0% C,M,Y).
